

NOTIFICATION OF MINISTRY OF NATURAL RESOURCES AND ENVIRONMENT

**About defining type, size and procedure for Project or Activity which
May affect community severely in respect of both the quality of Environment,
Natural Resources and Health that Government agency, State Enterprise
Or Private Sector should prepare environmental impact assessment report
(Second issue) B.E. 2553**

By virtue of section 46 and section 51 of the Promotion and Conservation of National Environment Quality Act, B.E. 2525 (1992) which some part of the Act is related to limited personal right and freedom and section 29 as well as section 33, 38, 41 and section 43 of the Constitution of the Kingdom of Thailand have been announced or prescribed by this law, Minister of the Ministry of Natural Resources and Environment, with the approval of National Environmental Board, shall notify as follow:

Clause 1. Nullify the message in type of project or activity size and principle, method and procedure in No. 7 in annex of Notification of the Ministry of Natural Resources and Environment About defining type, size and procedure for Project or Activity which may affect community severely in respect of both the quality of Environment, Natural Resources and Health that Government agency, State Enterprise or Private Sector should prepare environmental impact assessment report B.E. 2553 (1992) and validate the following message instead.
